JEFIS was the legacy system that pre-dated eCourts from 2005- 2016 and was used for Foreclosure and DC filings.

1. The Created Date is when the entry was filed.

2. The Filings column is blank as documents filed in JEFIS will not be visible in public access.

3. The Document type identifies the type of filing.

4. Document Description.

5. The Attorney column captures who submitted the filing.

6. The Firm Name column captures the affiliated firm of the attorney filer.
